## Terms and conditions

1. Registrations close one week before a programme starts. All registrations not paid two weeks prior to the event will be cancelled to accommodate people from the waiting list.
2. Bookings are only confirmed on receipt of a registration form, full payment, or a Purchase Order in the case of government departments.
3. Cancellations two weeks prior incur a 30% penalty. No refunds will be made on cancellations incurred one week prior to the programme. Applicants who have made payment may be substituted by another person at any time prior to the event without incurring an additional fee. The Ethics Institute must be notified of any changes in writing.
4. Late registrations will have a 24-hour window period to confirm their registration and payment.
5. All registrations not conforming to these terms and conditions will be cancelled at no cost to The Ethics Institute.
