



# Supporter Opportunities

Individuals can show commitment to advancing standards of ethical conduct in society by becoming Supporters of The Ethics Institute.

## What is The Ethics Institute?

The Ethics Institute is an independent institute producing original thought leadership and offering a range of ethics-related products and services. Our vision is *"Building an Ethically Responsible Society"*.

## What does it mean to be a Supporter?

Supporters represent our network of friends and associates who we hope will help us in achieving our vision. First and foremost, all Supporters make the following Pledge when they first sign up, and every year when they renew:

"I support The Ethics Institute's vision of building an ethically responsible society by acting ethically and promoting ethics in my sphere of influence".

While we require all Supporters to make this aspirational commitment, we do not police their adherence to it. It should therefore not be inferred that the conduct of any Supporter carries the stamp of ethical approval from The Ethics Institute.

## What are the benefits?

- Subscription to weekly news bulletin.
- Subscription to monthly newsletter.
- Discounts on events and training – including on those of TEI's partner organisations.
- Complimentary invitation to Annual Supporter Gathering (our chance to say, "thank you!").
- Free participation in Annual Masterclass with our subject matter experts.
- Annual certificates.
- Milestone certificates to recognise loyalty upon joining, and after five, ten, and fifteen years.

## What is the Supporter fee?

**2024/2025 SUPPORTER FEE: R1 240.00**

Supporters are contacted every year to renew their subscription. The fee is for a 12-month period starting in April of each year. New Supporters who join during the year pay a pro-rata fee in the first year to align with the annual renewal schedule. Students and pensioners pay 50% of the annual subscription fee, equal to R620.00 for 2024 - 2025.

## What about organisations?

We encourage organisations to pay a group subscription fee, **relative to the organisation's size**, for the subscriptions of a corresponding number of individual Supporters. Organisations funding a group of Supporters benefit from a special discount on The Ethics Institute's professional and advisory services.

### Small organisation

For a small organisation with between 0 and 25 employees, a maximum of **five** subscribers are allowed for a fee of

**R 6 200.00.**

### Medium organisation

For a medium organisation with between 26 and 200 employees, a maximum of **10** subscribers are allowed for a fee of

**R 12 400.00.**

### Large organisation

For a large organisation with more than 200 employees, a maximum of **20** subscribers are allowed for a fee of

**R 24 800.00.**

### NOTE:

Additional subscribers may be added for any group size, at an additional cost of R1 240.00 per person.

Should an organisation, however, select to subscribe less beneficiaries relative to the organisation's size, their listed beneficiaries may still receive individual discount benefits on training and events, but no group discount benefit on professional and advisory services will be granted.

- In the case of a conglomerate or group of companies, each entity is considered separate.
- Group fees are charged pro rata in the first year, except when joining on the 1st of April and thus subscribing for a full invoicing cycle.
