In pursuit of its vision of **building an ethically responsible society**, The Ethics Institute (TEI) offers a wide range of ethics-related training for diverse groups.

Why do ethics training?

Building an ethical culture in an organisation requires specialised knowledge and skills. That is why TEI offers a wide range of training programmes to equip those responsible for the governance or management of ethics in organisations.

An organisation's ethical culture is a collective effort. It is crucial to spread awareness of ethical standards and expectations across all levels of the organisation, which can be achieved through ethics training.

What does training involve?

- All programmes can be customised for public or private sector groups.
- Programmes can be customised to meet specific requirements and intended outcomes.
- To encourage active participation, group sizes should ideally not exceed 20 people.

The depth and duration of the training vary depending on the needs of the group. Training is delivered by experienced subject matter experts from TEI.
