## What does it mean to be a Supporter?

Supporters represent our network of friends and associates who support TEI with achieving our vision. Supporters are required to endorse our pledge on joining, and every year on renewal. The pledge is aspirational and is not being policed by TEI.

## What is the Supporter fee?

The Supporter fee is an annual financial contribution in support of the Institute's vision of building an ethically responsible society, and is renewable every twelve months, on 1 April. These fees contribute to the creation of original thought leadership and ethics toolkits for the benefit of the larger public.

A **reduced fee** of R650.00 is applicable to **Students** and **Pensioners**.

## What about organisations?

We encourage organisations to subscribe as a group, with fees based on their size. Group subscriptions include reduced rates for TEI's training, events, as well as professional and advisory services.

### Small organisation

For a small organisation with between 0 and 25 employees, a minimum of **five** subscribers are allowed for a fee of **R6 500.00** VAT inclusive.

### Medium organisation

For a medium organisation with between 26 and 200 employees, a minimum of **10** subscribers are allowed for a fee of **R13 000.00** VAT inclusive.

### Large organisation

For a large organisation with more than 200 employees, a minimum of **20** subscribers are allowed for a fee of **R26 000.00** VAT inclusive.

## NOTE:

1. Additional subscribers may be added for any group size, at an additional cost of R1 300.00 per person.
2. Organisations that subscribe fewer beneficiaries than their size requires will not be recognised as Group Supporters, although individual subscribers will still receive their benefits.
3. Organisations that meet the required number of subscribers based on their size will qualify as Group Supporters and receive applicable discounts.
4. For conglomerates or groups of companies, each entity will be regarded as a separate Group Supporter.
5. Should a new individual/Group Supporter join after the 1st of April, they will be charged a pro-rated fee and be aligned with the annual invoicing cycle in the following year.
