

Everybody is responsible for ethics in their organisations, but leading governance practices recommend that a specific individual – **the Ethics Officer – be responsible for the process of active, practical ethics management.**

The Ethics Officer Certification Programme (EOCP) is designed to train these individuals.

The Integrity Management Framework provides guidelines and principles for ethics management in the public sector. Furthermore, the King V Code on Corporate Governance indicates that an organisation's governance should be grounded in an ethical foundation, and also sets guidelines on the management of its ethics. The EOCP addresses these frameworks and is delivered by experts in the field.

Course content

Understanding ethics concepts and developing ethical reasoning skills

Developing an ethics management strategy

Developing ethics standards, codes of ethics, and ethics policies

Understanding the role of ethics in governance

Identifying the need for an ethics management programme

Ethics management toolbox, including training, raising awareness, and performance reporting

Setting up an ethics office

Assessing ethics-related risks and opportunities

Reporting ethics performance to management and governing bodies

Programme duration: Five days of contact sessions plus 90 days for the practicum.

Who should attend the EOCP?

- Persons responsible for managing ethics
- Human Resource Managers
- Forensic Officers and Internal Auditors
- Prospective and current Ethics Officers
- Risk Managers and Compliance Officers

Once applicants have completed the assessment, they will be required to submit the proof of completion, together with their fully completed registration form to The Ethics Institute (TEI) to conclude the registration process.

What are the entry requirements?

- **South African national holding a degree:** no further requirements.
- **South African national not holding a degree:** complete and pass an independent third-party assessment as pre-requisite. | Enquire [HERE!](#)
- **Foreign national with or without a degree:** complete and pass an independent third-party assessment as pre-requisite. | Enquire [HERE!](#)

Undertaking the assessment does not guarantee registration for the programme. TEI reserves the right to reject registrations.

After the course

Participants have 90 days to complete a practicum assignment for formal assessment. Thereafter, successful participants receive certification from [Stadio Higher Education](#). In addition, newly certified Ethics Officers receive public recognition on TEI's website as well as a complimentary one-year TEI Supporter subscription.

Programmes based in Gauteng will be held in Midrand, while the Western Cape programme will be conducted in Cape Town. Details about the specific venues will be made available in due course.
